YOU WILL RECEIVE AN EMAIL CONFIRMING YOUR ACCEPTANCE, APPLICATION AND PARTICIPATION.

GENERAL RULES AND REGULATIONS

APPLICATIONS WILL NOT BE REVIEWED OR CONSIDERED UNLESS ALL REQUIRED INFORMATION IS COMPLETED, FEES ARE INCLUDED (CHECK OR MONEY ORDER SHOULD BE MADE PAYABLE TO THE BIG HORN BASQUE CLUB - NO CASH PAYMENTS WILL BE ACCEPTED) AND THE APPLICATION IS SIGNED.

ALL VENDORS/EXHIBITORS SHOULD ARRIVE AT LEAST ONE HOUR PRIOR TO START OF THE FESTIVAL TO SET UP THEIR BOOTHS/ DISPLAYS. CHECK IN BEGINS AT 6:00 A.M. ON SATURDAY MORNING. YOU WILL RECEIVE YOUR BOOTH ASSIGNMENT AT THAT TIME. YOU MUST CHECK IN PRIOR TO SETTING UP.

DRIVING OR PARKING ON THE GRASS TO SET UP IS STRICTLY PROHIBITED. VENDORS WILL BE ALLOWED TO USE THE STREET ACCESS WHILE UNLOADING, BUT THEN MUST MOVE VEHICLES FROM THE FESTIVAL AREA NO LATER THAN 8:00 A.M.

POLICING WILL BE PROVIDED AT THE PARK, OFF FESTIVAL HOURS. HOWEVER VENDORS ARE STILL RESPONSIBLE FOR THEIR DISPLAYS AND MERCHANDISE. NEITHER THE BIG HORN BASQUE CLUB NOR CITY OF BUFFALO ASSUME ANY RESPONSIBILITY FOR THEFT, LOSS OR DAMAGE.

EXHIBITORS/VENDORS ARE NOT PERMITTED TO DISMANTLE THEIR BOOTH SPACES UNTIL AFTER 4:00 P.M. ON SUNDAY JULY 23, 2017. AFTER THE EVENT, EXHIBITORS WILL LEAVE

THEIR EXHIBIT SPACE CLEAN AND ALL TRASH SHOULD BE REMOVED FROM THE AREA.
